# 2005 Credit Union Department Satisfaction <u>Ouestionnaire Results</u>

According to the results of the Department's tenth annual survey, credit unions continue to believe that the Department provides quality service. The questionnaire, which was mailed in March to the presidents of all state-chartered credit unions, serves as a benchmark measurement in areas such as the appropriateness and thoroughness of examination procedures; the professionalism and responsiveness of examination teams; the procedures for processing applications; and solicits opinions on how to improve the quality and efficiency of the services provided by the Department.

Completion of the survey was voluntary and anonymous, and 67% of the presidents responded in 2005. When asked if the Department is providing quality service, 99% percent of the respondents replied affirmatively.

The Department extends its gratitude to all of the credit unions that took the time to complete this year's questionnaire. We sincerely appreciate the input and will use the results in the Department's decision-making process.

#### **Rule Review**

The Department is currently reviewing and considering for re-adoption, revision, or repeal Rules 91.401 (Purchase, Lease or Sale of Fixed Assets), 91.402 (Insurance for Members), 91.403 (Federal Parity Debt Cancellation Products), 91.405 (Records Retention), 91.406 (Credit Union Service Contracts), 91.407 (Electronic Notification), 91.408 (User Fee for Shared Electronic Terminal), 91.409 (Permanent Closing of an Office or Operation), 91.4001 (Authority to Conduct Electronic Operations), 91.4002 (Notice Requirement; Security Review), 91.5001 (Emergency Closing), and 91.5002 (Effect of Closing). Each rule will be reviewed to determine whether it is obsolete, whether the rule reflects current legal and policy considerations, and whether the rule reflects current procedures for the Department. In addition, the Department invites comments on how to make these rules easier to understand. For example:

- Do the rules organize the material to suit your needs? If not, how could the material be better organized?
- Do the rules clearly state the requirements? If not, how could the rule be more clearly stated?
- Do the rules contain technical language or jargon that isn't clear? If so, what language requires clarification?
- Would a different format (grouping and order of section, use of headings, paragraphing) make the rule easier to understand? If so, what changes to the format would make the rule easier to understand?
- Would more (but shorter) sections be better in any of the rules? If so, what sections should be changed?
