# <u>Updated Applications Available on the</u> <u>Department Website</u>

Due to the recent amendments approved by the Commission relating to Texas Administrative Code Section 91.301 the <u>Application to Amend Bylaws Community of Interest Geographic</u> and other forms have been updated. Credit unions are reminded that to ensure a smooth processing they should visit our <u>website</u> to pull the latest version of any application form whenever they begin the process of submitting an application.

# <u>Interagency Approval of Home Equity Rule</u> Amendments

On December 17th, the Finance Commission adopted rule amendments in 7 Texas Administrative Code Chapter 153, relating to home equity lending. The amendments were previously adopted by the Credit Union Commission on November 5, 2021. The amendments have been submitted to the Texas Register and became effective on January 6, 2022. The adopted amendments add language to various sections throughout Chapter 153, explaining that lenders may make disclosures and sign documents electronically (in accordance with the Texas Uniform Electronic Transactions Act and the federal E-Sign Act). The adoption also includes a revision to Section 153.17 regarding the authority of out-of-state banks and depository institutions to make home equity loans, as well as technical corrections.

### **Texas Laws & Regulations for Credit Unions**

Effective immediately, the Department is discontinuing sending individual amendment pages for hard copy versions of the Texas Finance Code (TFC) or the Credit Union related Rules found in the Texas Administrative Code (TAC). Instead, after an amendment, an email providing a summary of any amendments will be sent to each credit union, announcements will be made on our website and notice will be published in the newsletter notifying the industry that changes have been made. We will continue to incorporate changes as they are adopted by the Legislature and the Commission and make them available at our website for your convenience. The links for the FINANCE CODE and the Texas Administrative Code Rules for Credit Unions are embedded within this sentence. The website contains both unofficial consolidations of the appropriate TFC and TAC sections related to credit unions for research purposes (each in a single, pdf document), as well as links to the legislative websites which contain the official version of the TAC and TFC. The official websites for both the TFC and the TAC include information for anyone wishing to review the entire history of any particular section. Of course, any changes proposed regarding the TAC will continue to be published, in advance, in both our newsletter and through the Texas Register to ensure all members of the public have an opportunity to provide input to the Commission before any changes are considered.

The Department hopes ensuring updated digital versions of the TAC and TFC on our website will eliminate the need to physically amend hard copy versions of the regulations, provide consistently available, complete documents to all stakeholders and assist in maintaining their understanding of, and compliance with, the regulations.

# Apache Log4j Vulnerability Guidance

CISA and its partners, through the <u>Joint Cyber Defense Collaborative</u>, are responding to active, widespread exploitation of a critical remote code execution (RCE) vulnerability (<u>CVE-2021-44228</u>) in Apache's Log4j software library, versions 2.0-beta9 to 2.14.1, known as "Log4Shell." Log4j is very broadly used in a variety of consumer and enterprise services, websites, and applications—as well as in operational technology products—to log security and performance information. An unauthenticated remote actor could exploit this vulnerability to take control of an affected system.

Credit unions are urged to review and monitor the <u>Apache Log4j Security Vulnerabilities webpage</u> for updates and mitigation guidance.
