ARTICLES OF INCORPORATION

The undersigned persons, a majority of whom are residents of the State of Texas, and each of whom is at least eighteen (18) years old and has subscribed for at least ten (10) shares, and all of whom share the definable community of interest stated herein and otherwise qualify for membership in the credit union to be incorporated pursuant to these presents as defined below, hereby associate themselves together for the purpose of incorporating a credit union under pursuant to the laws of the State of Texas. The incorporators also represent that they desire to avail themselves, and those persons comprising the field of membership of the proposed credit union whom they represent, of the benefits of the credit union, and that they bind themselves to comply with all laws, bylaws, and rules applicable to credit unions doing business in this state.

FOURTH

The initial share accounts of the credit union shall have a par value as specified in the bylaws, of which not less than seventy (7) shares have been subscribed.

<u>FIFTH</u>

The credit union will not commence business until it has received for the issuance of it shares or deposits cash consideration of at least \$1,000, achieved a membership of at least 100 persons, all of whom shall meet the requirements for membership, and has fulfilled all agreements and conditions related to approval of an application for incorporation and issuance of a certificate of incorporation, and has so notified the Credit Union Department, State of Texas.

duties in administering the affairs of the credit union	n, that while being a director (s)he may delegate to

performance of those duties, and that (s)he will not k	knowingly violate or willingly permit to be violated
